General Information

(most common violations)

Exits: Exits are determined on the actual occupancy load of the building, all required exits are to be a minimum of 36" in width, and completely unobstructed. Required exits are also required to comply from the exit to the parking lot with all Michigan Handicap requirements including signs.

Exit signs: All required exits are required to have, "exit signs" at the exit, exit signs shall be placed so there is no point which exceeds 100' between the exit access and the nearest visible exit sign. (see your Fire Inspector for exceptions).

Occupancy Load: The designed occupancy load of a building shall be "posted" in a conspicuous location, (assembly areas within a building, shall have an independent posting for that area).

Emergency Lighting: Lighting shall be provided for all areas of the building, including all means of egress. (see the Fire Inspector for exceptions, power source and loss of power requirements).

Fire Protection Assemblies: In most case all commercial buildings have "Fire Rated" constructed assemblies in the structure. Over the course of time, equipment is changed and these assemblies are penetrated with out legal protection being installed or replaced.

Fire Protection Systems: If your building has a fire protection system it must be maintained at all times. This would include a Fire Suppression System, limited area sprinklers, specific area sprinkler, and alarms or smoke detectors. These systems shall not be disarmed for any reason without first notifying the Fire Department and/or the Township Building Department.

Storage: As a building owner your are allowed a specific degree of storage, however, all storage must comply with all "Material Safety Data" requirements, and can not exceed the allowances of, Table 307.7(1) of the, "Michigan Building Code". Violations of this Section will result in the reclassification of your building to "High Hazard".

Interior Finishes: From time to time new building owners/leases's wish to make there operation more attractive. it is important to understand that all interior finishes are "regulated" and must comply with the requirements of ASTM 119 and/or ASTM E84 and Chapter 8 of the Code.
